Abstract:

This research study aims to evaluate the impact of government policies on youth empowerment and participation in Aizawl City, using a comparative approach. Convenience sampling was used to select participants, and a sample size of 100 participants, aged 18-25 years, was included in the study. The data collected revealed that most participants are aware of government policies specific to youth empowerment, and a significant percentage have participated in government-sponsored programs. The study also identified the most significant government policies, challenges hindering youth empowerment, and suggestions for improvement. The findings highlight the need for increased awareness, resource allocation, and opportunities for skill development and entrepreneurship. The study concludes with recommendations for addressing these challenges and fostering youth empowerment and participation in Aizawl City.

on the satisfaction levels of youth aged 18-30 years residing in Aizawl City.

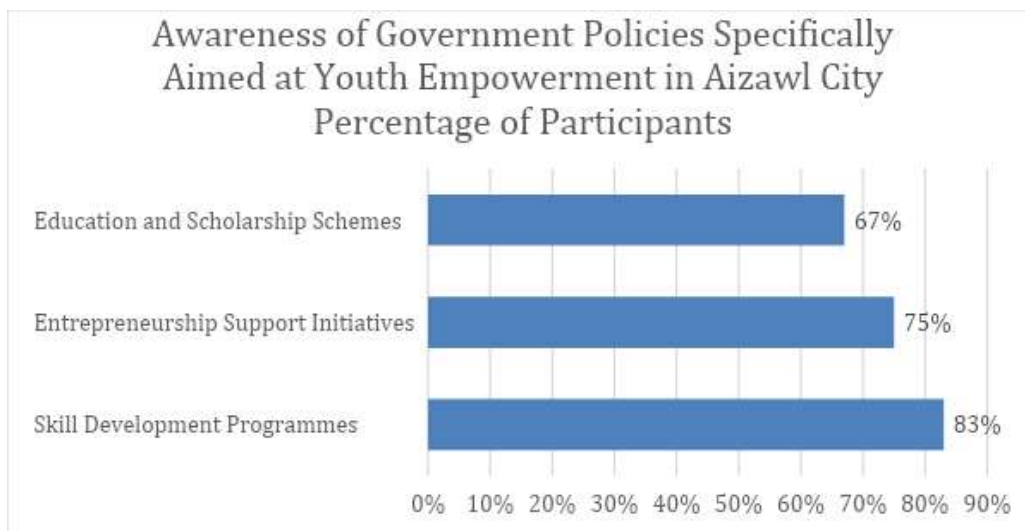

Chart 1: Awareness of Government Policies Specifically Aimed at Youth Empowerment in Aizawl City

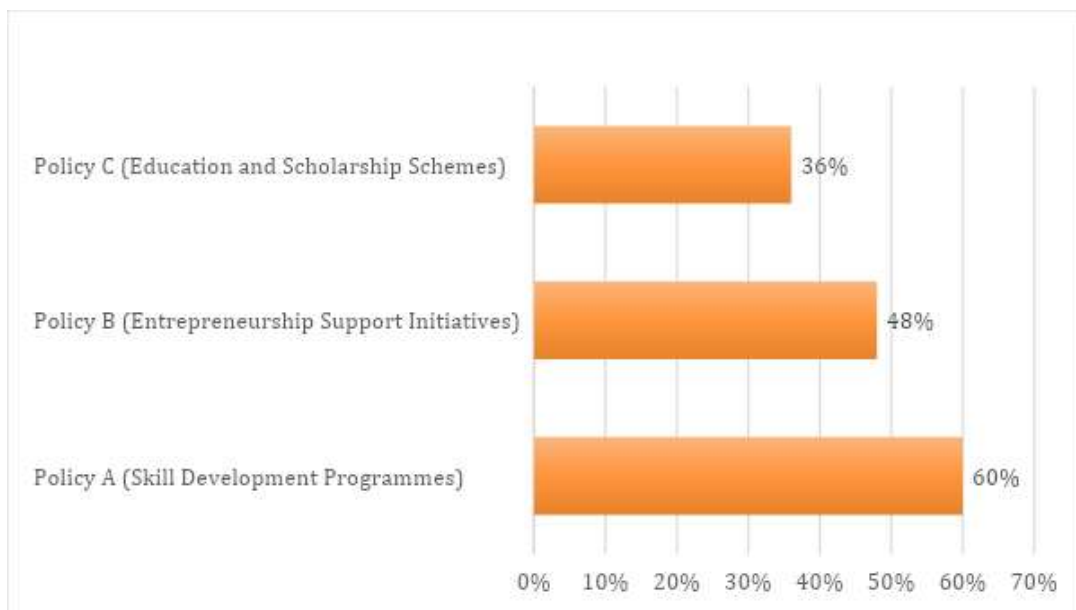

Chart 2: Participation in Government-Sponsored Programs or Initiatives for Youth Empowerment in Aizawl City



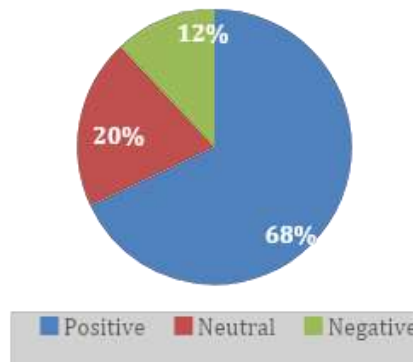

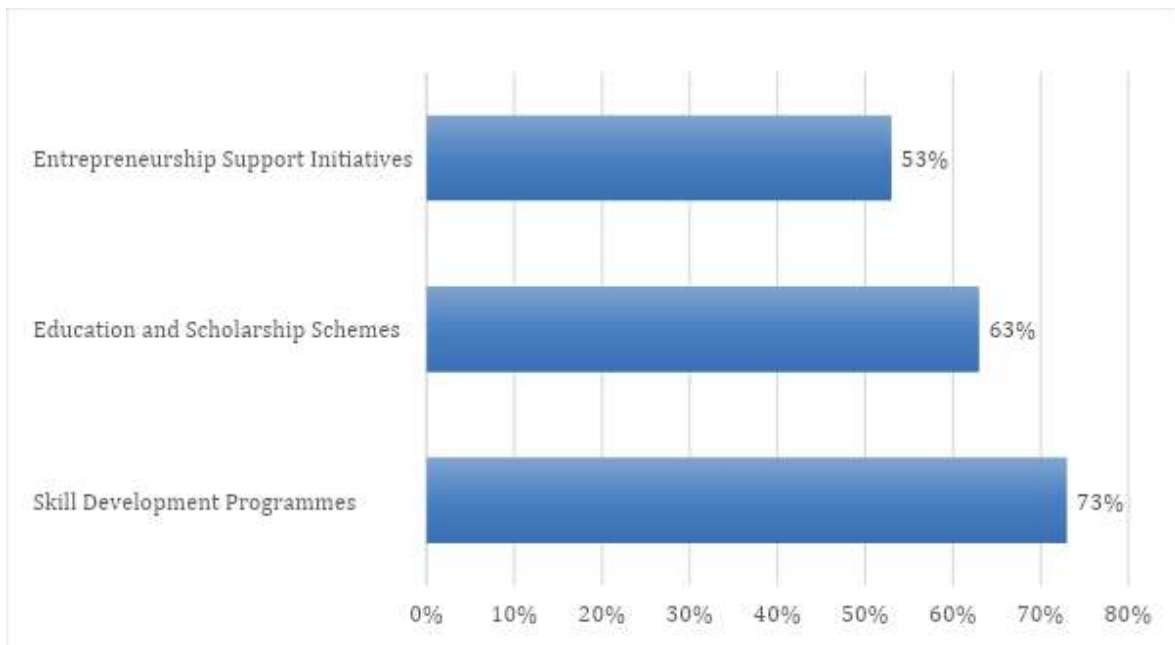

Education and Scholarship Schemes: A significant percentage of participants (63%) identify education and scholarship schemes as an essential government policy. This reflects the understanding of the role education plays in empowering the youth and providing them with opportunities for personal growth and career advancement. To enhance the effectiveness of this policy, the government should ensure equal access to quality education for all youth, particularly those from marginalized backgrounds. Additionally, the government should expand scholarship programs to cover a broader range of fields and levels of education, including vocational and technical training.

Entrepreneurship Support Initiatives: A notable percentage of participants (53%) recognize the significance of entrepreneurship support initiatives. This highlights the importance of creating an enabling environment for youth entrepreneurship, promoting innovation, and facilitating the establishment and growth of youth-led businesses. To further strengthen this policy, the government can provide financial support, mentorship programs, and access to networks and markets for young entrepreneurs. Additionally, simplifying business registration processes and reducing bureaucratic hurdles can encourage more youth to embark on entrepreneurial ventures.

Chart 5: Challenges or Barriers Hindering Youth Empowerment and Participation in Aizawl City

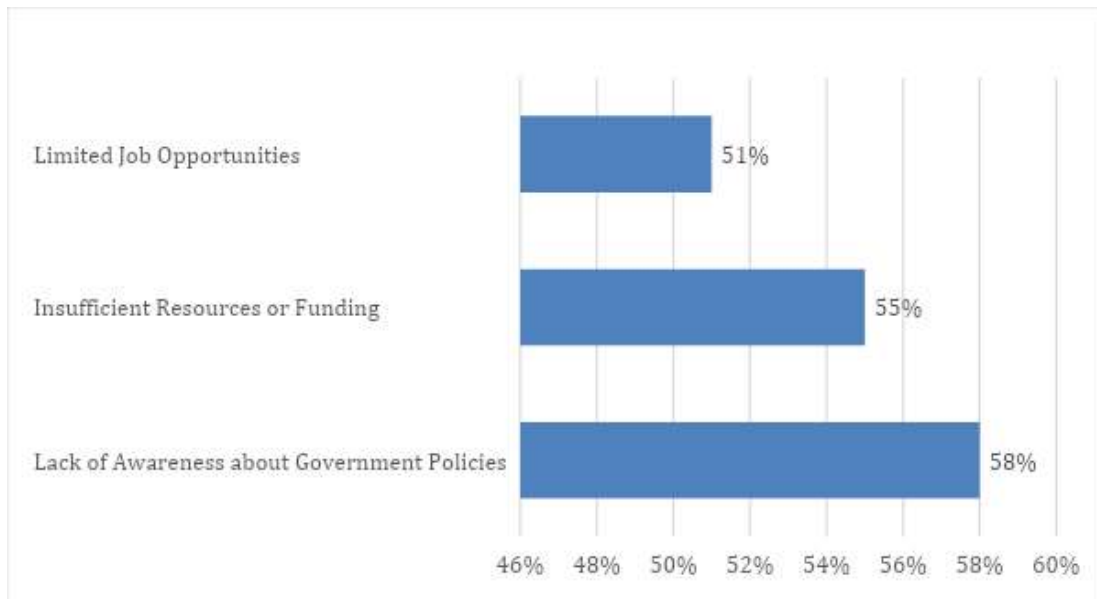


Chart 5 reveals the challenges that impede youth empowerment and participation in Aizawl City, namely Lack of Awareness about Government Policies, Insufficient Resources or Funding, and Limited Job Opportunities. The majority of the participants, accounting for 58%, emphasized the lack of awareness about government policies as a significant barrier. To tackle this issue, suggestions include organizing information campaigns through various channels, collaborating with educational institutions to integrate government policies into the academic curriculum, and creating dedicated online platforms or mobile applications for easy access to information.

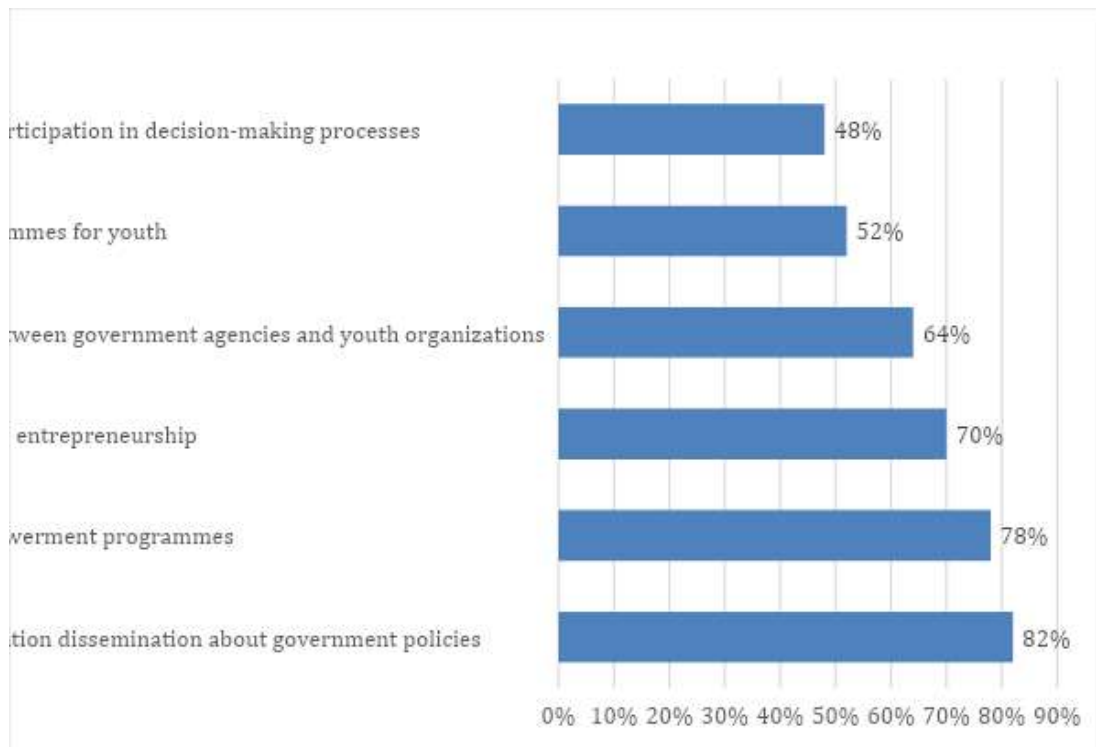
Insufficient resources or funding was identified as a barrier by 55% of the participants. Limited resources hinder the implementation of youth empowerment initiatives and restrict support for young individuals. To address this challenge, suggestions include increasing budget allocation for youth empowerment, collaborating with private sector organizations and NGOs through public-private partnerships to mobilize additional resources, and establishing grant and funding programs specifically catered to youth-led initiatives.

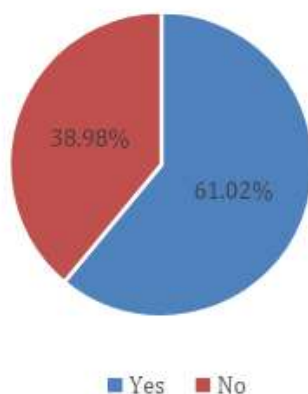
