The State Government has implemented several provisions aimed at facilitating easier access to property for women, as evidenced by the amendments made in the Hindu Succession Act, Tamil Nadu Amendment, 1989. Moreover, the government has established 568 Registrar and Joint Registrar offices across the state, the highest number in India, to accommodate the significant number of property registrations taking place. Setting up each office initially incurs a cost of Rs. 13 lakh, with an additional recurring expenditure of Rs. 15 lakh per annum to the State The values of family and society are often upheld by women, who have historically served as rulers, scholars, scientists, and in various

other roles. However, recent times reveal a stark portrayal of the deteriorating status of women in our society. Women are frequently portrayed as dependent and subordinate to men, with their rights often marginalized. Despite ongoing efforts by feminist groups to highlight women's rights, there remain numerous areas where societal attention is yet to be directed, particularly concerning women's inheritance rights. Inheritance rights are governed by a myriad of religious and social norms, presenting formidable barriers to women's property rights. 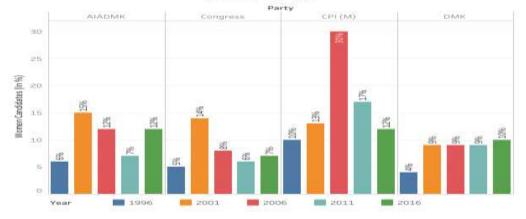
Political Participation
